## Primary Job Duties/Responsibilities

- Regularly collect, analyze, and prepare data on the performance of Road sector (Roads, Highways, Tunnels, Bridges etc). Create and maintain structured data/ Management Information Systems (MIS), pertaining to the Road sector.
- Provide periodic inputs to various departments to assist in finalizing risk analysis/ project appraisal using relevant data.
- Support and verify financial models/ assumptions submitted by borrowers during the due diligence process.
- Collaborate/ Liaison with Government agencies, intermediaries, research agencies, and publication agencies to gather and compile data on Road sector. Provide informed inputs to the business/ processing teams as needed.
- Review and analyze third-party reports, technical reports, and industry reports and provide pertinent insights to the business/ processing teams on a regular basis.
- Maintain a comprehensive database of technical parameters specific to Road & Transport industry, including industry benchmarks.
- Assist business/ processing teams in understanding technical aspects, emerging trends, assumption, risks, and mitigation strategies related to individual projects, sectors, and sub-sectors.
- Provide support during the implementation and operations phases, addressing issues arising from technical and other review reports

- Periodic knowledge sharing and policy advocacy with business/ processing teams as needed.
